With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 19 September 2016 and 23 September 2016 acquired no. 1,656 treasury shares at an average unit price of € 9.0612 per share, for a total amount of € 15,005.38.
