With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 26 September 2016 and 30 September 2016 acquired no. 2,200 treasury shares at an average unit price of € 9.0690 per share, for a total amount of € 19,951.74.
