Turin, 3 October 2016. ASTM S.p.A. announces that, in the context of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 28 April 2016, acquired, in the period from 26 September to 30 September 2016 included, n. 36,500 of the Company's ordinary shares (equal to 0.04% of the share capital), at an average price of € 9.6860 per share for a total amount of about € 353.5 thousands.

Since the start of the share buy-back, ASTM S.p.A. acquired a total of n. 618,800 own shares (corresponding to 0.63% of the share capital) for a total amount of € 6.38 million.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 6,011,828 own shares (6.07% of the share capital) of which n. 5,931,450 shares directly owned and n. 80,378 shares indirectly through the controlled company Autostrada Albenga Garesio Ceva S.p.A. (n. 58,878 shares) and the controlled company ATIVA S.p.A. (n. 21,500 shares).
