## UPDATE ON THE SHARE BUY-BACK PROGRAM

*Milan, October 3<sup>rd</sup>, 2016* - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 18<sup>th</sup>, 2016, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period September 26<sup>th</sup> - 30<sup>th</sup> 2016 a total of 40,000 ordinary Amplifon S.p.A. shares, equivalent to 0.018% of the share capital, at an average unit price of Euro 9.127 per share, for a total consideration of Euro 365,098.24.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 3,413,167 shares.

As of September 30<sup>th</sup>, 2016, Amplifon owned n. 6,403,833 of its shares, corresponding to 2.835% of the Company's share capital.
