Turin, 17 October 2016. ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 28 April 2016, acquired, in the period from 10 October to 14 October 2016 included, n. 94,000 of the Company's ordinary shares (equal to 0.09% of the share capital), at an average price of € 9.5112 per share for a total amount of about € 894.1 thousands.

Since the start of the share buy-back, ASTM S.p.A. acquired a total of n. 751,928 own shares (corresponding to 0.76% of the share capital) for a total amount of € 7.65 million.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 6,144,956 own shares (6.21% of the share capital) of which n. 6,064,578 shares directly owned and n. 80,378 shares indirectly through the controlled company Autostrada Albenga Garesio Ceva S.p.A. (n. 58,878 shares) and the controlled company ATIVA S.p.A. (n. 21,500 shares).
