## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 7 November 2016 and 11 November 2016 acquired no. 2,800 treasury shares at an average unit price of € 8.9710 per share, for a total amount of €25,118.79.
