UPDATE ON THE SHARE BUY-BACK PROGRAM

Milan, November 28th 2016 - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 18th, 2016, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period November 21st - 25th, 2016 a total of 65,000 ordinary Amplifon S.p.A. shares, equivalent to 0.029% of the share capital, at an average unit price of Euro 9.056 per share, for a total consideration of Euro 588,613.22.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 3,556,542 shares.

As of November 25th, 2016, Amplifon owned n. 6,666,458 of its shares, corresponding to 2.949% of the Company's share capital.
