## UPDATE ON THE SHARE BUY-BACK PROGRAM

---

*Milan, December 12<sup>th</sup> 2016* - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 18<sup>th</sup>, 2016, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period December 5<sup>th</sup> - 9<sup>th</sup>, 2016 a total of 65,000 ordinary Amplifon S.p.A. shares, equivalent to 0.029% of the share capital, at an average unit price of Euro 9.330 per share, for a total consideration of Euro 606,470.93.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 3,563,249 shares.

As of December 9<sup>th</sup>, 2016, Amplifon owned n. 6,789,751 of its shares, corresponding to 3.002% of the Company's share capital.
