Snam 2017 Financial calendar

San Donato Milanese (Milan), 24 January 2017 – Snam announces the calendar of corporate events and the dates of the publication of its financial results that will be examined by the Board of Directors and the Shareholder Meeting during 2017.

In continuity with the quarterly report provided in the past, in order to provide regular and transparent information to the market and investors, Snam will continue on a voluntary basis to publish periodic financial information in addition to the Annual and Interim Financial Report, pursuant to article 82-ter of the Issuer Regulation.

Starting from the 2017 financial year, the quarterly report contained in the press release disclosed to the market will concern at least the following quantitative indicators:

- Key operating figures
- Operating profit
- Net result for the period
- Net financial debt and its evolution
- Net equity and its evolution.

The press release will contain further qualitative and quantitative information providing a better explanation of the business evolution, where necessary.

The quarterly information will be approved by the Board of Directors and disclosed to the public in accordance with the schedules set in the Financial calendar of the Group and in any case within 45 days from the close of the first and third quarter of each year.

The usual conference call for in-depth analyses with journalists and financial analysts will be maintained.
