With the aim of assuring to the Financial Community a continuing and regular flow of information regarding the performance of the Company, also in consideration of the fact that Tecnoinvestimenti is a member of the STAR Segment of the Milan Bourse, according to art. 82-ter of the Regulation adopted by Consob with resolution no. 11971 of 14 May 1999 ("Issuers' Regulation"), as modified by Resolution no. 19770 of 26 October 2016, the Board of Directors of Tecnoinvestimenti S.p.A. announces that the Company, in addition to the annual and half-yearly reports provided for in Article 154-ter, paragraph 1 and 2 of Legislative Decree. n. 58/98 ("TUF"), will continue to approve and make available to the public the "Interim Managerial Reports" ending the quarters on 31 March and 30 September of each year, within the terms and in the manner provided for by the Regulation governing the companies being part of the STAR segment, that is within 45 (forty-five) days after the close of the reference reporting period.

## THE TECNOINVESTIMENTI GROUP

The Sales & Marketing Solutions Business Unit, through Co.Mark, offers solutions and tools to small and medium-sized companies to support international commercial expansion.
