OVERDUE DEBT POSITIONS OF THE TISCALI GROUP AS OF DECEMBER 31 2016

On December 31 2016, overdue trade payables, amounted to EUR 59.4 million (*). The overdue financial debts amounted to EUR 3,3 million. There were also overdue tax debts for approximately EUR 16.9 million.

There are also overdue debts towards the employees for EUR 1,4 million.

POSSIBLE REACTION OF THE CREDITORS OF THE GROUP AT DECEMBER 2016

There have been no suspensions of relationships with suppliers, which affected the course of business.

As of December 31 2016, there were solicitations for payment only within the ordinary course of business. On that date the injunctions for payment received by the Company and not paid off because still in negotiation or opposition, amounted to EUR 6.1 million, while the total injunctions for payment received amounted to EUR 7,2 million.

RELATIONSHIPS WITH RELATED PARTIES OF TISCALI S.P.A. AND TISCALI GROUP

The Tiscali Group holds relationships with related parties on terms deemed customary in the respective reference markets, taking into account the characteristics of goods and services provided.
