## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 30 January 2017 and 3 February 2017 acquired no. 4,333 treasury shares at an average unit price of € 10.5290 per share, for a total amount of €45,622.33.
