## NOTICE OF CALL OF THE SHAREHOLDERS' GENERAL MEETING OF ISAGRO S.P.A.

Milan, March 23<sup>rd</sup>, 2017 – In accordance with the requirements envisaged by the applicable laws, the notice of call of the Ordinary Shareholders' General Meeting of Isagro S.p.A. to be held in Milan, via Giovanni da Procida n. 11, Auditorium of Federchimica, on Wednesday April 26<sup>th</sup>, 2017, at 03.00 p.m., in single call, was published, also on the newspaper Italia Oggi, on March 23<sup>rd</sup>, 2017.
