**Reno De Medici S.p.A.** informs that, in the period between 27<sup>th</sup> and 31<sup>st</sup> March 2017, the Company bought on the Mercato Telematico Azionario (Italian Equities Market) n. 376,053 ordinary shares at the average price of 0.3594 euro, for a total consideration of 135.024,21 euro, pursuant to the authorization to purchase treasury shares approved by the Shareholders' Meeting held on 2 November 2015.
