AMPLIFON: ANNOUNCEMENT OF CHANGES TO VOTING RIGHTS

(ART. 85-BIS PARAGRAPH 4-BIS OF ISSUERS' REGULATION AND ART. 2.6.2. PARAGRAPH 1 PART A) OF BORSA ITALIANA S.P.A. MARKETS RULES)

Milan, April 10th, 2017 - Amplifon S.p.A. announces that on April 2nd, 2017 a change in the Company's voting took place as an effect of the accrual on the increased voting rights on some shares of the Company (as better identified below) pursuant to art. 13 of the Bylaws, which provides the power that, pursuant to article 127-quinquies of Legislative Decree. 58/1998, ("TUF"), to each share held by the same party for an uninterrupted period of no less than twenty-four months starting from the date of registration on the list contemplated in the same article shall be assigned two votes.

The table below summarizes the current situation of voting rights:

- Amplifon S.p.A. share capital equals € 4.525.701,72 and consists of n. 226.285.086 shares with a nominal value of € 0,02 per share;
- On April 2nd, 2017, the right to the increase accrued for n. 111.369.596 shares (two voting rights per share) out of a total of n. 226.285.086 shares, which therefore brought a change in total voting rights from 226.285.086 to 337.654.682;
- Pursuant to subsection 8 of art 127-quinquies of the TUF, the increase of voting rights is calculated for the determination of the quorums for the Shareholders' Meeting to be validly held and for resolutions to be approved.

It should also be noted that are registered in the list of increased voting rights further n. 997.771 shares, whose increase is in process of maturation.
