UPDATE ON THE SHARE BUY-BACK PROGRAM

Milan, April 18th, 2017 - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 18th, 2016, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period April 10th - 13rd, 2017 a total of 52,000 ordinary Amplifon S.p.A. shares, equivalent to 0.023% of the share capital, at an average unit price of Euro 11.382 per share, for a total consideration of Euro 591.889,35.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 3,741,990 shares.

As of April 13rd, 2017, Amplifon owned n. 7,640,010 of its shares, corresponding to 3.376% of the Company's share capital.
