## CHANGES IN 2017 CORPORATE CALENDAR

Cesena, May 10<sup>th</sup>, 2017 - Finanziaria Industriale S.p.A. (the "Company") announces the following changes to the 2017 financial calendar in respect of article 2.6.2, paragraph 1, letter b) of the Regulation about the markets organized and managed by Borsa Italiana S.p.A..

With regard to the additional financial information referred to in art. 82-ter of Consob Regulation no. 11971/1999 and subsequent amendments and additions, the Company informs that it is going to communicate, on a voluntary basis, the additional periodic financial information to the Annual Financial Statement and the Half-Yearly Report, regarding the Interim Reports (as of March 31<sup>st</sup> and September 30<sup>th</sup>), in order to guarantee information transparency and continuity. The interim contents reported will be in line and continuity with those published before.
