VOLUNTARY PUBLICATION OF QUARTERLY FINANCIAL INFORMATION

Assago, May 11, 2017 – On a consistent basis with the development of the reference legislative framework ((Legislative Decree 25/2016, which was followed by Consob Resolution No. 19770/2016), as already announced in the press release for the approval of the 2017 financial calendar, published on January 30, 2017, Italiaonline S.p.A. announces its intention to continue to publish, on a voluntary basis and up to a different resolution, an additional quarterly periodic financial information with respect to the annual and semi-annual financial report, evolving its disclosure, as from the first quarter of 2017, by means of a more concise representation of its business focused on the significant information.

Content of the quarterly periodic financial information

The Group's quarterly periodic financial information will concern at least the main consolidated economic and financial indicators and, where appropriate, it may include additional qualitative and quantitative information on business performance.

Disclosure

The quarterly periodic financial information shall be published via a press release.

Timing for the approval and publication of the quarterly periodic financial information

The quarterly periodic financial information shall be approved by the Board of Directors at meetings to be held no later than 45 days from the closure of the first and third quarters of each year. They shall be published following their said approval.
