## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 8 May 2017 and 12 May 2017 acquired no.6,750 treasury shares at an average unit price of €13.7200 per share, for a total amount of €92,609.93.
