## **UPDATE ON THE SHARE BUY-BACK PROGRAM**

*Milan, May* 22<sup>nd</sup>, 2017 - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 20<sup>th</sup>, 2017, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period May 15<sup>th</sup> - 19<sup>th</sup>, 2017 a total of 65,000 ordinary Amplifon S.p.A. shares, equivalent to 0.029% of the share capital, at an average unit price of Euro 12.044 per share, for a total consideration of Euro 782,879.50.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 for a total of n. 3,763,823 shares.

As of May 19<sup>th</sup>, 2017, Amplifon owned n. 7,826,177 of its shares, corresponding to 3.459% of the Company's share capital and to 2.320% of the total share capital in voting rights.
