Provaglio d'Iseo (BS), 12 June 2017: Gefran Spa announces an important contract for supplying inverters with a leading international manufacturer of elevators

The inverter is an electronic device that mounted in the lifts regulates the operation of the electric motor, allows the control of speed and position, and guarantees remarkable energy savings.

The agreement foresees the production of inverters for the American market and will have a duration of 3 years, for a total value of approximately 23 million euros.

The inverters destined for this supply will be produced entirely in Italy, in the Gefran site of Gerenzano (Varese); the first deliveries are planned in 2018.
