## Informativa sull'acquisto di azioni proprie

San Donato Milanese (Milano), 7 luglio 2017 – Nel periodo compreso tra il 29 giugno e il 6 luglio 2017 Snam ha acquistato n. 759.068 azioni proprie al prezzo medio unitario di 3,8466 euro, per un controvalore complessivo di 2.919.866,79 euro. Gli acquisti sono stati effettuati nell'ambito dell'autorizzazione al programma di acquisto di azioni proprie deliberata dall'Assemblea degli Azionisti di Snam del 1° agosto 2016, il cui avvio e successive modifiche sono stati comunicati al mercato il 7 novembre 2016, il 7 dicembre 2016, il 31 gennaio e il 7 marzo 2017, ai sensi dell'art. 144-bis del Regolamento Consob 11971/1999.
