## Report on the purchase of treasury shares

*San Donato Milanese (Milan), 14 July 2017* – During the period from 7 to 13 July 2017, Snam acquired n. 680,000 own shares at an average price per share equal to 3.8441 euro, for an aggregate amount of 2,613,997.00 euro. The purchases were made within the authorization to the treasury shares purchase plan approved at Snam's Shareholder Meeting on 1 August 2016. The start and the subsequent amendments of the purchase plan were announced to the market on 7 November 2016, 7 December 2016, 31 January and 7 March 2017, pursuant to art. 144-bis of Consob Regulation 11971/1999.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buyback program, the details of the purchases of treasury shares on the MTA (Electronic Stock Market) on a daily basis are reported below:

Since the start of the purchase plan Snam acquired n. 84,022,152 own shares (equal to 2.40% of the share capital), for an aggregate amount of 309,734,174.94 euro.

Following the purchases announced today, and taking into consideration the treasury shares already held, on 13 July 2017 Snam holds n. 85,149,402 shares equal to 2.43% of the share capital.
