SABAF: THE SHAREHOLDERS' MEETING APPOINTS PIETRO IOTTI TO SUPPLEMENT THE BOARD OF DIRECTORS

The Shareholders' meeting of Sabaf S.p.A., held today in Ospitaletto (BS) under the chairmanship of the *interim* Chief Executive Officer Gianluca Beschi, approved the appointment of Pietro Iotti to supplement the Board of Directors following the resignation of a member in April. The elected Director will remain in office until the expiry of the mandate of the current Board of Directors and i.e. until the approval of the 2017 financial statements.

Pietro Iotti held important managerial positions in Smeg and Technogym and is currently Chairman and Chief Executive Officer of Interpump Hydraulics S.p.A., the reference company of the hydraulic division of the Interpump group.
