UPDATE ON THE SHARE BUY-BACK PROGRAM

Milan, July 24th, 2017 - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 20th, 2017, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period July 17th - 19th, 2017 a total of 39,000 ordinary Amplifon S.p.A. shares, equivalent to 0.017% of the share capital, at an average unit price of Euro 12.119 per share, for a total consideration of Euro 472,659.85.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 for a total of n. 5,117,438 shares.

As of July 21st, 2017, Amplifon owned n. 7,117,562 of its shares, corresponding to 3.145% of the Company's share capital and to 2.167% of the total share capital in voting rights.
