## **UPDATE ON THE SHARE BUY-BACK PROGRAM**

Milan, September 4<sup>th</sup>, 2017 - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 20<sup>th</sup>, 2017, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period August 28<sup>th</sup> - September 1<sup>st</sup>, 2017 a total of 65,000 ordinary Amplifon S.p.A. shares, equivalent to 0.029% of the share capital, at an average unit price of Euro 12.006 per share, for a total consideration of Euro 780,410.54.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 for a total of n. 5,759,746 shares.

As of September 1<sup>st</sup>, 2017, Amplifon owned n. 6,968,254 of its shares, corresponding to 3.079% of the Company's share capital and to 2.122% of the total share capital in voting rights.
