Milan, 26 September 2017 - Snam, a European leader in gas infrastructure, and Baker Hughes, a GE Company (BHGE), global leader in digital services and solutions supporting the energy industry, have signed a Memorandum of Understanding aimed at launching a collaboration to develop integrated cutting-edge technology solutions across the entire gas infrastructure value chain.

The Memorandum with BHGE enables Snam to share and develop with an internationally renowned player the best knowledge and technology, especially in the R&D and digital sectors, strengthening its leadership in terms of innovation and helping to position natural gas as a key energy source for decarbonisation.

The collaboration is aimed, among other things, at promoting energy efficiency processes as well as ever-increasing digitization in the natural gas sector, with a view to developing the role of gas in the energy mix consistent with the environmental sustainability objectives.
