GIMA TT opera nel settore delle macchine automatiche per il *packaging* dei prodotti derivati del tabacco e in particolare dei c.d. prodotti di nuova generazione (*reduced-risk products*).

Il prezzo di apertura è stato pari a Euro 14,25, in crescita del 14% rispetto al prezzo di offerta (pari a Euro 12,50).

Il titolo ha scambiato nella prima giornata n. 11.731.599 azioni ed ha chiuso la seduta a un prezzo di Euro 15,30, in aumento del 22,4% rispetto al prezzo di offerta.
