**OPENJOBMETIS TAKES PART IN THE STAR CONFERENCE IN LONDON ON 9 OCTOBER**

**Milan, 5 October 2017** – Openjobmetis S.p.A. (Borsa Italiana: **OJM**), one of the leading Employment Agencies, listed on the STAR segment of the Stock Market, will take part in the STAR Conference organised by Borsa Italiana on 9 and 10 October at the London Stock Exchange.

An event dedicated to companies in the STAR segment, where the top management of the companies will meet a wide range of foreign institutional investors to tell about business innovations and future growth plans during one-to-one meetings and group meetings.

On the first day, the Managing Director Rosario Rasizza and the CFO Alessandro Esposti will present to more than 20 foreign institutional investors the economic and financial performances achieved in the first half of 2017, showing double digit increases in Total revenues (+34%), a more than doubled profit for the period and a significant decrease in the net financial position, plus the sector's macro view and the prospects for development of Openjobmetis over the next few years.

Rosario Rasizza, Managing Director of Openjobmetis, commented as follows: *“We are present at the STAR Conference for the fourth time after the 2015 listing, with many new features compared to the last time. In fact, today Openjobmetis is a real public company, with a free float of more than 68%, about 50% of which is represented by foreign institutional investors. This result was also achieved thanks to the visibility gained during the meetings with foreign investors in the institutional setting of the Milan and London markets”.*

**Openjobmetis - an overview:** Openjobmetis S.p.A. is an Employment Agency established in 2011 as a result of the merger of Openjob S.p.A. and Metis S.p.A., with their know-how and unique expertise that has distinguished them for over 16 years. Listed since December 2015 on the STAR segment of the screen-based stock exchange (MTA) operated by Borsa Italiana, Openjobmetis S.p.A. is positioned among the leading Italian operators in its field, with revenues of approximately EUR 461.0 million in the year ended 31 December 2016. Openjobmetis S.p.A. relies on a network of more than 120 branches distributed throughout Italy and it operates through a series of specialised areas: Healthcare, Industrial, Banking and Finance, Large-Scale Retail Trade, I&CT, Horeca, Family Care, Agro-Industrial and Diversity Talent and Naval. The range of services is completed by the subsidiary Seltis Srl, specialised in the recruitment and selection of middle/top level employees. In December 2015, CRIBIS D&B awarded the CRIBIS D&B Rating 1 to Openjobmetis, recognising the company at the highest level of economic and financial reliability, and in 2017 further improved the rating by assigning the title of CRIBIS Prime Company, demonstrating the company's high credit standing and economic and financial strength.
