## FINANCIAL CALENDAR 2018

**Massimo Zanetti Beverage Group S.p.A.: the B.o.D. approved the financial calendar for the year 2018.**

*Villorba (Treviso, Italy), November 10, 2017* - The Board of Directors of Massimo Zanetti Beverage Group S.p.A. ("MZBG" or the "Company") approved the 2018 Financial Calendar indicating when the Company's and/or Group's accounts will be examined and published as follows:

- **28<sup>th</sup> February 2018:** Board of Directors approves Statutory and Financial Statements at December 31<sup>st</sup>, 2017
- **10<sup>th</sup> April 2018:** Annual Shareholders' Meeting
- **10<sup>th</sup> May 2018:** Board of Directors approves Interim Report at March 31<sup>st</sup>, 2018
- **8<sup>th</sup> August 2018:** Board of Directors approves Half Year Financial Statements at June 30<sup>th</sup>, 2018
- **8<sup>th</sup> November 2018:** Board of Directors approves Interim Report at September 30<sup>th</sup>, 2018

Please note that the Company avails of the exemption pursuant to Art. 2.2.3, paragraph 3 of the Rules of the Markets Organized and Managed by Borsa Italiana S.p.A.. Accordingly, in lieu of the Report for the fourth quarter of 2017, within 90 days of the end of the year, the Annual Financial Report will be published in accordance with Article 154-ter, paragraph 1 of Legislative Decree no. 58 of February 24, 1998.

In conjunction with the above Board of Directors meetings, the Company has planned specific conference calls with the financial community, during which the Company's and/or Group's accounts will be presented.

Any amendments to the above calendar will be promptly notified to the market.
