OPENJOBMETIS WILL PARTICIPATE IN THE FIRST MIDCAP EVENT IN MADRID

Milan, November 13, 2017 - Openjobmetis S.p.A. (Borsa Italiana: **OJM**), one of the leading employment agencies listed on the STAR segment of the Italian Stock Exchange, announces that it will be present at the first Midcap European event in Madrid (Spain). The event, organized by Intermonde SIM for the first time in Spain, will allow many important foreign institutional investors, to meet and learn about publicly-traded Italian companies that excel in their respective fields and are characterized by a strong growth potential through one on one meetings.

The event will be attended by the Managing Director, Rosario Rasizza and the CFO, Alessandro Esposti.

On this occasion, management will present the results for the first nine months of the year, which showed a two-figure improvement over 2016, closing with a net income of € 9.8 million in September 2017 with respect to € 5.4 million in September 2016, 30% higher than in September 2016, and an improvement in the net financial position with a reduction of € 7.0 million as of 31 December 2016.

Openjobmetis SpA relies on a network of 125 branches distributed throughout Italy and operates through a series of specialised areas: Healthcare, Industrial, Banking and Finance, Large-Scale Retail Trade, I&CT, Horeca, Family Care, Agro-Industrial, Diversity Talent and Marine. The range of services is completed by the subsidiary Seltis Srl, specialised in the recruitment and selection of middle/top level employees.

In December 2015, CRIBIS D&B awarded the CRIBIS D&B Rating 1 to Openjobmetis, recognising the company at the highest level of economic and financial reliability and in 2017, it further upgraded the rating, awarding it the title of CRIBIS Prime Company, which bears witness to the high level of creditworthiness and economic and financial solidity.
