IL CONSIGLIO DI AMMINISTRAZIONE ESERCITA LA DELEGA CONFERITA DALL'ASSEMBLEA DEI SOCI DEL 28 SETTEMBRE 2017 PER L'AUMENTO DEL CAPITALE SOCIALE DI BANCA CARIGE

Genova, 14 novembre 2017 – Banca Carige rende noto che il Consiglio di Amministrazione, in data odierna, ha deliberato di esercitare la delega *ex* art. 2443 del Codice Civile, conferita dall'Assemblea dei Soci del 28 settembre 2017, per aumentare il capitale sociale per un importo massimo complessivo di Euro 560 milioni (comprensivo del sovrapprezzo) in forma scindibile (l'"**Aumento di Capitale**"), di cui:

- fino ad un massimo di Euro 500 milioni con attribuzione del diritto d'opzione (l'"Aumento di Capitale in Opzione") da offrire ai Soci aventi diritto in proporzione alle azioni ordinarie e/o di risparmio possedute;
- fino ad un massimo di Euro 60 milioni con esclusione o limitazione del diritto di
