## OPENJOBMETIS PARTICIPATES IN THE EUROPEAN MIDCAP EVENT IN GENEVA

Milan, 27 November 2017 – Tomorrow, Openjobmetis S.p.A. (Italian Stock Exchange: **OJM**), one of the leading Employment Agencies, listed on the STAR segment of the stock exchange, will be present at the European Midcap Event in Geneva. The event, organised by Intermonte SIM, provides many European institutional investors with the opportunity to meet, on a one2one basis, Italian enterprises that excel in their respective sectors, characterised by huge potential for growth.

The Chief Executive Officer, Rosario Rasizza, and the CFO, Alessandro Esposti, will attend the event.

The four young project designers had the opportunity to present their idea to Rosario Rasizza and, after a careful evaluation, painstaking market research and feasibility studies, Openjobmetis decided to develop and implement the project, identifying Daniela Pomarolli as the project manager.
