***Florence/Cavriago (RE), 30 November 2017.***

B&C Speakers and Landi Renzo consider it appropriate to inform the market that the *closing* of the transaction for the acquisition by B&C Speakers of Eighteen Sound Srl (a subsidiary of Landi Renzo, through the subsidiary A.E.B. SpA), originally scheduled on November 30th in the announcement of the binding offer of October, 2nd, will be postponed for a few days for technical and organizational reasons; such a move does not imply any risk of non-completion of the transaction, which will materialize by the end of the current year.
