UPDATE ON THE CONCLUSION OF THE SHARE BUYBACK PROGRAM IN CONNECTION WITH FINCANTIERI'S "PERFORMANCE SHARE PLAN 2016 – 2018"

Trieste, 4 December 2017 – FINCANTIERI S.p.A. (hereafter also "Fincantieri" or "the Company") announces that in the period between 27 November and 30 November 2017 purchased on the Borsa Italiana, Bats, Chi-X and Turquoise trading venues through Exane BNP Paribas a total of 535,930 ordinary shares, equal to approximately 0.03% of the total number of shares issued. The shares were purchased at an average price of Euro 1.1972 per share, for a total consideration of Euro 641,615.30.

The Company also announces the conclusion of the share buyback program for 4,706,890 ordinary shares, equal to 0.28% of the issued share capital, announced on 25 October 2017 in accordance with the resolution approved at the Company's General Meeting of Stockholders on 19 May 2017,
