Snam issues 2 years private placement for 350 million euro

San Donato Milanese (Milan), 22 January 2018 – Today Snam S.p.A. (rated Baa1 by Moody's, BBB+ by S&P and BBB+ by Fitch) issued a private placement with primary institutional investors, for an amount of 350 million euro, tenor of 2 years and variable yield equal to 3-months Euribor plus 0.15%.

Today's issue is consistent with the optimization process of Snam's debt structure and cost of capital, in line with the Company's targets.

The notes, issued under Snam's € 10 billion Euro Medium Term Notes Programme which was approved by the Board of Directors on 6 October 2017, will be listed on the Luxembourg Stock Exchange.
