# PRELIMINARY SALES REVENUE 2017 OF €583,9 MILLION **UP BY 26,7% COMPARED TO 2016**

Milan, 30 january 2018 – The Board of Directors of Openjobmetis S.p.A. (Borsa Italiana: OJM), one of the leading Employment Agencies, listed on the STAR segment of the Stock Market – operated by Borsa Italiana, analysed preliminary sales revenue as at 31 december 2017.

Preliminary sales revenue for the whole of 2017 amounted to €583,9 million against €460,9 million last

The increase of 26,7% (€123 million) is mainly due to higher revenue from the core business, namely "temporary employment" (+26,9% compared to 2016), "recruitment and selection" (+9,7% compared to 2016) and revenue from other activities (+12,8% compared to 2016).

Openjobmetis at a glance: Openjobmetis SpA is a private employment agency created in 2011 through the merger of Openjob SpA and Metis SpA, which have pooled together the know-how and unique expertise that has distinguished them for over 17 years. Since December 2015, Openjobmetis is the first and only private employment agency listed on the Italian Stock Exchange, in the STAR segment and is one of the leading Italian operators in its field, with revenues of approximately €461 million in the year ended 31 December 2016.

Openjobmetis SpA relies on a network of 127 branches distributed throughout Italy, specialising in the following areas: Healthcare, Industrial, Banking&Finance, Mass Retailing, ICT, Hotel and Catering, Family Care, Agro-Industrial, Diversity Talent and Naval. The range of services is completed by the subsidiary Seltis Srl, which focuses on the recruitment and selection of middle/top-level executives. In December 2015, CRIBIS D&B awarded the CRIBIS D&B Rating 1 to Openjobmetis, recognising the company at the highest level of economic and financial reliability and in 2017, it further upgraded the rating, awarding it the title of CRIBIS Prime Company, which bears witness to the high level of creditworthiness and economic and financial solidity.
