OPENJOBMETIS PARTICIPATES IN THE EUROPEAN MIDCAP EVENT OF FRANKFURT

Milan, 05 February 2018 – Tomorrow, Openjobmetis S.p.A. (Italian Stock Exchange: OJM), one of the leading Employment Agencies, listed on the Stock Market - STAR segment, will be present at the 11th edition of the European Midcap Event in Frankfurt.
