UPDATE ON THE SHARE BUY-BACK PROGRAM

Milan, February 5th, 2018 - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 20th, 2017, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period January 29th - February 2nd January, 2018, a total of 40,000 ordinary Amplifon S.p.A. shares, equivalent to 0.018% of the share capital, at an average unit price of Euro 14.177 per share, for a total consideration of Euro 567,061.36.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 for a total of n. 6,615,037 shares.

As of February 2nd, 2018, Amplifon owned n. 7,249,963 of its shares, corresponding to 3.203% of the Company's share capital and to 2.204% of the total share capital in voting rights.
