## BANCA IMI: THE BOARD OF DIRECTORS APPROVES THE DRAFT FINANCIAL STATEMENTS AS AT 31 DECEMBER 2017

Milan, 23 February 2018 - The Board of Directors of Banca IMI, the investment bank within the Intesa Sanpaolo Group, led by CEO **Mauro Micilo** and General Manager **Massimo Mocio**, has approved the draft individual financial statements and the consolidated financial statements as at 31 December 2017 in a meeting held today and chaired by **Gaetano Miccichè**.

The proposed allocation of Banca IMI S.p.A. profit for the year includes the distribution of a dividend of 548.6 million to the Parent Company Intesa Sanpaolo. For additional detailed financial information please refer to the press release dated 05 February 2018.

The draft individual financial statements and the reports accompanying them, will be submitted to the Shareholders' Meeting convened for 18 April 2018 on first call, and 24 April 2018 on second call. They will be filed at the Company headquarters and at Borsa Italiana within the deadlines set out by law.

The Manager responsible for preparing the Company's financial reports, Angelo Bonfatti, declares, pursuant to Paragraph 2 of Article 154 bis of the Consolidated Law on Finance, that the accounting information contained in this press release corresponds to what appears in the documentary entries, books and accounting entries.
