With reference to the buy-back programme approved by the shareholders on 5 May 2015, 28 April 2016 and 27 April 2017, and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 19 February 2018 and 23 February 2018 acquired no. 9,796 treasury shares at an average unit price of € 18.5607 per share, for a total amount of € 181,820.91.
