Subject **Wind turbine supply, transport and erection agreement with Vestas signed**

Pollenza, 1st March , 2018

Fintel Energia Group S.p.A., a leading Italian green IPP, has signed today, through its Serbian local subsidiary MK Fintel Wind A.D, a contract for the supply, transport and erection of 20 wind turbines Vestas V126 -3,45 MW for its phase I Kosava development located in Vrsac, Serbia.

The 69 MW wind farm, whose construction works started in July 2017 will be completed within the 2019. The Kosava facility is expected to slash the CO2 emissions in Serbia by approximately 170,000 tons per annum delivering clean energy to approximately 57.000 Serbian families and employing over 90 people for its construction and 10 for its operation.

Along with the other two operating wind farms Kula and La Piccolina the Group can now count on a total installed power of 87 MW and a pipeline in excess of 300 MW in various stages of development.
