## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015, 28 April 2016 and 27 April 2017, and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 5 March 2018 and 9 March 2018 acquired no. 6,727 treasury shares at an average unit price of € 17.8008 per share, for a total amount of € 119,745.72.
