Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015, 28 April 2016 and 27 April 2017, and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 3 April 2018 and 6 April 2018 acquired no. 5,847 treasury shares at an average unit price of € 18.2184 per share, for a total amount of € 106,522.89.
