## UNICREDIT COMPLETA LA CESSIONE DI AZIONI PARI A CIRCA IL 4% DEL CAPITALE SOCIALE ORDINARIO DI ERG

Il corrispettivo dell'operazione ammonta a circa Euro 111,84 milioni, risultanti dalla vendita di n. 6.012.800 azioni ordinarie di ERG ad un prezzo di Euro 18,60 per azione

**Milano, 10 aprile 2018.** Facendo seguito a quanto comunicato in data odierna, UniCredit S.p.A. ("**UniCredit**") annuncia che è stata completata con successo l'operazione di cessione a investitori istituzionali di 6.012.800 azioni ordinarie di ERG S.p.A. ("**ERG**"), pari a circa il 4% del capitale sociale della stessa, cedute da UniCredit al prezzo di Euro 18,60 per azione (l'"**Offerta**").

Il regolamento dell'operazione è previsto in data 13 aprile 2018.

Il corrispettivo complessivo è stato pari a circa Euro 111,84 milioni.

Citigroup, Morgan Stanley e UniCredit Corporate & Investment Banking hanno agito quali *joint bookrunner* dell'Offerta (i "**Joint Bookrunner**").

Con questa operazione UniCredit porta a termine il percorso avviato con l'investimento in ERG Renew S.p.A. nel 2014.
