ORDINARY MEETING**

Poste Italiane S.p.A. Financial Statements for the year ended 31 December 2017. Reports of the Board of Directors, the Board of Statutory Auditors, and the Audit Firm. Related resolutions. Presentation of the consolidated financial statements for the year ended 31 December 2017.

Dear Shareholders,

A special file made available to the public at the Company's registered office and on its website within the time period established by the law, to which we therefore refer you, contains the proposed financial statements of Poste Italiane S.p.A. for the year ended 31 December 2017 – including the separate Accounts of BancoPosta's Ring-Fenced Capital (established by the Company with effect from 2 May 2011 by a resolution of the extraordinary shareholders' meeting held on 14 April 2011, and whose functioning is governed by special rules available at www.posteitaliane.it) – showing net income for the year of 617.0 million euro, as well as the Poste Group's consolidated financial statements for the year ended 31 December 2017 (showing a net result for the year attributable to the Group amounting to 689 million euro), which the Board of Directors approved on 29 March 2018.

Considering the foregoing, we submit the following

Proposal

The present Shareholders' Meeting of Poste Italiane S.p.A.:

- having examined the proposed financial statements of Poste Italiane S.p.A. for the year ended 31 December 2017, with the related reports of the Board of Directors, the Board of Statutory Auditors, and the External Auditor;

- having acknowledged the “consolidated non-financial declaration”, prepared in accordance with Legislative Decree n. 254/16 and included in the Report on operations for the year ended 31 December 2017, with the report of the External Auditor;
- having acknowledged the consolidated financial statements for the year ended 31 December 2017, with the related reports of the Board of Directors and the External Auditor;

resolves

to approve the financial statements of Poste Italiane S.p.A. for the year ended 31 December 2017, including the separate Accounts of BancoPosta's Ring-Fenced Capital.

REPORT OF THE BOARD OF DIRECTORS ON THE SECOND ITEM ON THE AGENDA OF THE ORDINARY MEETING

Allocation of net income for the year.

Dear Shareholders,

We remind you that the dividend policy – which was approved by the Board of Directors at its meeting on 26 February 2018 and communicated to the public at the presentation of the strategic plan 2018-2022 – provides an amount of the dividend for the year 2017 equal to 0.42 euro per share, increasing by 5% per annum up to 2020, and a minimum payout of 60% from 2021 onward.

Considering that the Poste Italiane Group's net consolidated income for 2017 amounts to 689,394 thousand euro (entirely attributable to the Group), in accordance with the dividend policy referred to above, we propose the distribution of a dividend amounting to 0.42 euro per share (a total of about 548.6 million euro), to be paid in June 2018 in accordance with the dates communicated to the market on 20 December 2017, when the corporate calendar of events for the year 2018 was released, and precisely: (i) 20 June 2018 as the payment date, (ii) 18 June 2018 as the “ex dividend” date, and (iii) 19 June 2018 as the record date (i.e., the date of entitlement to the aforesaid dividend).

In light of all the foregoing, and considering that:

- the legal reserve exceeds the maximum of one-fifth of the share capital (as required by article 2430, paragraph 1, of the Italian Civil Code); and
- as provided for by article 8.3 of the Rules for BancoPosta's Ring-fenced Capital (the text of which is available on the Company's website www.posteitaliane.it), given the absence of contributions by third parties to BancoPosta's Ring-fenced Capital, Shareholders' Meetings resolve – including upon proposal by the Board of Directors – on the allocation of the Company's net income for the year, and specifically: (i) the part

regarding BancoPosta's Ring-fenced Capital, as shown in the related report, taking into account its specific rules and, in particular, the necessity of complying with the capital requirements of prudential supervision, and thus (ii) the remaining part, including the part of the net income referred to under (i) not allocated to the ring-fenced capital; we submit for your approval the following

Proposal

The present Shareholders' Meeting of Poste Italiane S.p.A., having examined the report of the Board of Directors,

resolves

1. to allocate the net income of BancoPosta's Ring-fenced Capital of 584,979,647 euro to the disposal of the Company;
2. to allocate Poste Italiane S.p.A.'s net income for 2017, amounting to 616,965,039 euro, as follows:
 - 2.1) 548,566,200 euro to the distribution to the Shareholders, as a dividend, 0.42 euro for each of the 1,306,110,000 ordinary shares in circulation on 18 June 2018, the day scheduled as the ex-dividend date,
 - 2.2) 68,398,839 euro to "Retained Earnings";
3. to pay the aforesaid dividend for 2017 of 0.42 euro per ordinary share – before withholding tax, if any – from 20 June 2018, with the "ex-dividend" date of coupon n. 3 falling on 18 June 2018 and the record date (i.e., the date of entitlement to the payment of the aforesaid dividend pursuant to article 83-terdecies of Legislative Decree n. 58 of 24 February 1998 and article 2.6.6, paragraph 2, of the Regulations of the markets organized and managed by Borsa Italiana S.p.A.) falling on 19 June 2018.

REPORT OF THE BOARD OF DIRECTORS ON THE THIRD ITEM ON THE AGENDA OF THE ORDINARY MEETING

Remuneration Report.

Dear Shareholders,

The Remuneration Report was prepared in accordance with the provisions of article 123-*ter* of Legislative Decree n. 58 of February 24, 1998 and article 84-*quater* of Consob Resolution n. 11971 of May 14, 1999.

According to the provisions of the sixth paragraph of article 123-*ter* of Legislative Decree n. 58 of February 24, 1998, a Shareholders' Meeting must resolve in favor of or against the Section I of the Remuneration Report, which explains the Company's policy regarding the remuneration and incentive plans for members of the board of directors and other executives who have strategic responsibilities, as well as the procedures used for the adoption and implementation of such policy. The resolution is not binding.

On the other hand, for the remuneration and incentive plans for personnel under BancoPosta's Ring-Fenced Capital – described in a document attached to Poste Italiane's Remuneration Report prepared pursuant to the Bank of Italy's Circular n. 285, First Part, Title IV, Chapter 2 of December 17, 2013, as well as the EBA guidelines and EBA Regulatory Technical Standard (RTS) in force – the resolution of the Shareholders' Meeting will be binding. It should also be noted that, following the inspection carried out on compliance of the practices with respect to the remuneration and incentives policy for personnel of BancoPosta's Ring-Fenced Capital in force in 2017, a general level of adequacy was found. Together with the attachment regarding the guidelines on the remuneration policies and incentive programs of BancoPosta's Ring-Fenced Capital, the Remuneration Report is contained in a document – to which we refer you – made available at the same time as the present report.

In light of the foregoing, we submit for your approval the following

Proposal

The present Shareholders' Meeting of Poste Italiane S.p.A. resolves in favor of the Section I of the Remuneration Report, which explains the Company's policy regarding the remuneration and incentive plans for members of the board of directors and other executives with strategic responsibilities, as well as the procedures used for the adoption and implementation of such policy.

The present Shareholders' Meeting also approves the guidelines on the policies of remuneration and incentive plans of BancoPosta's Ring-Fenced Capital, which are attached to the Remuneration Report.

**REPORT OF THE BOARD OF DIRECTORS ON THE FOURTH ITEM ON THE AGENDA OF THE
ORDINARY MEETING**

Equity-based incentive plan, addressed to the material Risk Takers of BancoPosta's Ring-Fenced Capital.

Dear Shareholders,

You have been convened to discuss and resolve – in accordance with article 114-*bis*, paragraph 1, of Legislative Decree n. 58 of 24 February 1998 – with regard to the approval of the incentive plan, based upon financial instruments, addressed to the Material Risk Takers of BancoPosta's Ring-Fenced Capital (the “Plan”), which was finalized by the Board of Directors upon proposal by the Remuneration Committee.

The Plan includes the following incentive schemes:

- 1) the Short-Term Incentive “MBO” scheme 2018;
- 2) the three-year Deliver Long Term Incentive scheme.

We note that, although the Plan does not provide for the award of Poste Italiane S.p.A. shares to the participants, it includes incentive mechanisms for the Material Risk Takers of BancoPosta's Ring-Fenced Capital, with the award of 50% of such incentive in the form of phantom stocks (i.e., units tied to the value of Poste Italiane S.p.A. shares).

Specifically, the total amount of the variable component to which each Participant is entitled will be determined, with the consequent establishment of the quantity of phantom stocks (amounting, as stated above, to 50% of the variable component) that is due each Participant.

The mechanism for converting the phantom stocks into a monetary bonus will be based on the average market value recorded by Poste Italiane S.p.A. shares during the thirty days with the stock exchange open preceding the award of the phantom stocks themselves.

For the aforesaid reasons, the Plan may therefore be called a “compensation plan based on financial instruments” pursuant to article 114-*bis*, paragraph 1, of Legislative Decree n. 58 of 24 February 1998.

In accordance with the provisions of article 84-bis, paragraph 1, of Consob Resolution n. 11971 of 14 May 1999, the features of the Plan are described in detail in a special informative document – to which we refer you – made available to the public at the same time as the present report.

All the above being understood, we submit for your approval the following

Proposal

Having examined the explanatory report of the Board of Directors and the informative document on the Plan prepared pursuant to article 84-bis, paragraph 1, of Consob Resolution n. 11971 of 14 May 1999, the Annual General Meeting of Poste Italiane S.p.A.

resolves:

1. to approve the Plan upon financial instruments and reserved for the Material Risk Takers of BancoPosta's Ring-Fenced Capital, whose features are described in the informative document – prepared pursuant to article 84-bis, paragraph 1, of Consob Resolution n. 11971 of 14 May 1999 and made available to the public at the Company's registered office, on the authorized storage mechanism "eMarket STORAGE" (www.emarketstorage.com), and on the Company's website
2. to vest the Board of Directors, which may sub-delegate, with all the powers necessary to concretely implement the incentive plan, to be exercised in accordance with the indications in the related informative document. To this end, the Board of Directors may, by way of example and not exhaustively, see to the execution of the Plan, as well as the approval of the regulations for carrying out the Plan.

**REPORT OF THE BOARD OF DIRECTORS ON THE FIFTH ITEM OF THE AGENDA OF THE
ORDINARY MEETING**

Authorization for the acquisition and the disposal of own shares. Related resolutions.

Dear Shareholders,

You have been convened to discuss and resolve upon granting the Board of Directors with an authorization for the acquisition and the disposal of own shares of the Company, pursuant to Articles 2357 and 2357-*ter* of the Italian Civil Code, for the purposes and in accordance with the terms and modalities described below.

1. Reasons for the authorization request

The request for authorization is aimed at granting the Board of Directors with the right to purchase and dispose of own shares of the Company, in compliance with the relevant applicable (also European Union) laws and the accepted market practices in force from time to time, for the following purposes:

- a) to offer to Shareholders an additional tool for monetizing their investment;
- b) to fulfil the obligations arising from any equity plans for Directors or employees of Poste Italiane S.p.A. (“Poste Italiane”) or of its subsidiaries or affiliates;
- c) to set up a share portfolio to serve extraordinary financial transactions or for other purposes deemed to be in the financial, business and/or strategic interest of Poste Italiane;
- d) to support the market liquidity of Poste Italiane’s stock, in order to facilitate the regular execution of trading and to avoid irregular price fluctuations, as well as to regularize the trend of negotiations and quotations against temporary distortions due to volatility excess or low trading liquidity;
- e) to optimize the Group capital structure.

2. Maximum number of shares to which the authorization refers

It is hereby proposed that the Shareholders' Meeting authorizes the acquisition of own shares, in more instalments, up to a maximum amount of 500 million euros and to a maximum number of 65.3 million Poste Italiane ordinary shares, representing approximately the 5% of the Company's share capital, which is currently divided into no. 1,306,110,000 ordinary shares without par value.

Pursuant to Article 2357, paragraph 1, of the Italian Civil Code, the acquisitions shall be made within the limits of distributable net income and of the available reserves, as per the most recent duly approved financial statements. In this regard, please note that the available reserves resulting from Poste Italiane's financial statements as of December 31, 2017, which is submitted to the approval of this Shareholders' Meeting, are equal to an overall amount of approximately 1,028 million euros, once the distribution of dividends and the recapitalization of the BancoPosta's Ring-Fenced Capital will have been resolved.

The authorization includes the right to dispose, in one or more instalments, of all or part of the own shares in portfolio, also before having reached the maximum amount of shares that can be purchased as well as, as the case may be, to buy-back the shares, provided that the own shares held by the Company and, if applicable, by its subsidiaries, do not exceed the limit established by the authorization.

3. Further useful information for assessing compliance with Article 2357, paragraph 3, of the Italian Civil Code

At the date of this report, the share capital of Poste Italiane S.p.A. amounts to 1,306,110,000.00 euros, divided into 1,306,110,000 ordinary shares without par value.

Currently the Company does not hold own shares in portfolio, neither through its subsidiaries.

4. Term for which the authorization is requested

The authorization to purchase own shares is requested for the maximum term provided for by Article 2357, paragraph 2, of the Italian Civil Code, equal to eighteen months starting from the date on which the Shareholders' Meeting grants the authorization. During such

period, the Board of Directors may carry out the acquisitions freely determining the relating amount and times, in compliance with the relevant applicable (also European Union) laws and the accepted market practices in force from time to time.

Given the absence of any legislative restriction and taking into account the need to grant the Company with as much operational flexibility as possible, the requested authorization does not provide for any term in relation to the disposal of the own shares purchased.

5. Minimum and maximum consideration

Under the requested authorization, purchases shall be made at a price which shall be determined from time to time, taking into account the specific modality selected to carry out the transaction and in compliance with the regulatory provisions (also of European Union), if any, or the accepted market practices in force from time to time, provided that in any case such price shall not be 10% lower or higher than the official price recorded by the Poste Italiane's stock on the *Mercato Telematico Azionario* organized and managed by Borsa Italiana S.p.A. in the trading day preceding each transaction.

Under the same requested authorization, the sale or any other disposal of own shares in portfolio shall take place in accordance with the terms and conditions determined from time to time by the Board of Directors, in compliance with the purposes and criteria illustrated above, and in any case according to the limits (if any) provided for by the relevant applicable (also of European Union) laws and the accepted market practices in force from time to time.

6. Modalities for the acquisition and disposal of own shares

Given the several purposes indicated in paragraph 1 above, under the requested authorization, acquisitions shall be carried out in compliance with most of the modalities provided for by the relevant applicable (also European Union) laws and the accepted market practices in force from time to time.

Such modalities are currently set forth by Article 132 of Legislative Decree no. 58 of February 24, 1998 (the "Consolidated Financial Act"), by Article 144-bis of Consob Resolution no. 11971 of May 14, 1999 (the "Issuers' Regulation"), by Article 5 of the

Regulation (EU) no. 596/2014 of the European Parliament and of the Council of April 16, 2014 and its relating implementing measures, as well as by the market practices accepted by Consob with Resolution no. 16839 of March 19, 2009.

In particular, in compliance with Article 132, paragraph 1, of the Consolidated Financial Act, the acquisitions of own shares shall be carried out ensuring the equal treatment among Shareholders, according to the modalities established by Consob within the ambit of Article 144-bis, paragraph 1, of the Issuers' Regulation.

Under the same requested authorization, acts of disposal and/or use of own shares shall be made with the modalities deemed the most appropriate and compliant with the interest of the Company and, in any case, in accordance with the relevant applicable (also of European Union) laws and the accepted market practices in force from time to time.

7. Information on the relation, if any, between the purchase of own shares and the purpose of reducing the share capital

This request for authorization to purchase own shares is not instrumental to the reduction of the share capital.

We therefore submit to your approval the following

The Shareholders' Meeting of Poste Italiane S.p.A., having examined the explanatory report of the Board of Directors,

resolves

1. to authorize the Board of Directors – pursuant to Article 2357 of the Italian Civil Code – to acquire shares of the Company, in more instalments, for a period of eighteen months starting from the date of this resolution, for the purposes provided for by the explanatory report of the Board of Directors relating to this item on the agenda of today's Shareholders' Meeting, according to the terms and conditions specified below:
 - the maximum number of shares to be purchased is equal to no. 65,300,000 ordinary shares of the Company, representing approximately the 5% of the share capital of

- Poste Italiane S.p.A., which is currently divided into no. 1,306,110,000 ordinary shares without par value, up to a maximum amount of 500 million euros; the acquisitions shall be made within the limits of distributable net income and of the available reserves, as per the most recent duly approved financial statements;
- the acquisitions shall be made at a price which shall be determined from time to time, taking into account the specific modality selected to carry out the transaction and in compliance with the regulatory provisions (also of European Union), if any, or the accepted market practices in force from time to time, provided that in any case such price shall not be 10% lower or higher than the official price recorded by the Poste Italiane S.p.A.'s stock on the *Mercato Telematico Azionario* organized and managed by Borsa Italiana S.p.A. in the trading day preceding each transaction;
 - the acquisitions shall be carried out ensuring the equal treatment among Shareholders and according to the modalities provided for by the relevant applicable (also of European Union) laws and the accepted market practices in force from time to time, and in any case pursuant to Article 144-bis, paragraph 1, of the Issuers' Regulation;
2. to authorize the Board of Directors – pursuant to Article 2357-ter of the Italian Civil Code – to dispose, in one or more instalments, for an unlimited period of time, of all or part of the own shares held in portfolio, also before having reached the maximum amount of shares that can be purchased, as well as, as the case may be, to buy-back the shares, provided that the own shares held by the Company and, if applicable, by its subsidiaries, do not exceed the limit established by the authorization referred to in point 1 above. The acts of disposal and/or use of the own shares in *portfolio* shall be carried out for the purposes provided for by the explanatory report of the Board of Directors relating to this item on the agenda of today's Shareholders' Meeting, according to the terms and conditions specified below:
- the sale or any other disposal of own shares in *portfolio* shall be carried out with the modalities deemed the most appropriate and compliant with the interest of the Company and, in any case, in accordance with the relevant applicable (also European Union) laws and the accepted market practices in force from time to time;

- the sale or any other disposal of own shares in portfolio shall take place in accordance with the terms and conditions determined from time to time by the Board of Directors, in compliance with the purposes and criteria as per this authorization, and in any case according to the limits (if any) provided for by the relevant applicable (also European Union) laws and the accepted market practices in force from time to time;
 - the own shares related to equity incentive plans, if any, shall be assigned in accordance with the modalities and terms provided for by the regulations of the same plans;
3. to grant the Board of Directors – and, on its behalf, the Chief Executive Officer, with the right to sub-delegate – with any power needed in order to implement the resolutions as per points 1 and 2 above, carrying out all the activities that may be necessary, advisable, instrumental and/or related to the successful outcome of the same resolutions, as well as to provide the market with the due disclosure in compliance with the relevant applicable (also European Union) laws and the accepted market practices in force from time to time.

REPORT OF THE BOARD OF DIRECTORS ON THE SIXTH ITEM OF THE AGENDA OF THE ORDINARY MEETING

Additional fees regarding the external audit assignment related to the Poste Italiane S.p.A. Financial Statements and the consolidated financial statements for each fiscal year of the three-years period 2017-2019 pursuant to articles 13, 14, and 16 of Legislative Decree n. 39/2010.

Shareholders,

This point concerns the supplement to the fee for the assignment to perform the statutory audit of the accounts entrusted to PricewaterhouseCoopers S.p.A for the financial years from 2017 to 2019.

The Board of Directors therefore submits for the approval of this Meeting the reasoned proposal formulated by the Board of Statutory Auditors pursuant to Article 13(1) of Legislative Decree No 39 of 27 January 2010 concerning the supplement to the fee paid to PricewaterhouseCoopers S.p.A for financial years from 2017 to 2019 set out below.

“Shareholders,

With the resolution passed by the Shareholders' Meeting of 14 April 2011, at the reasoned proposal of the Board of Statutory Auditors, the assignment, for financial years 2011 to 2019, to perform the statutory audit of the annual and consolidated financial statements of Poste Italiane and the consolidated condensed half-year financial statements of the Poste Italiane Group, and the audit of the accounting unbundling activities of Poste Italiane S.p.A, was entrusted to PricewaterhouseCoopers S.p.A (hereinafter, also PwC) in accordance with Articles 13 and 17 of the version then in force of Legislative Decree No 39/2010.

With respect to the date of conferring the nine-year assignment, the following should first be noted.

- *The rules governing statutory audits have recently undergone a wide-ranging review. The aim was to provide greater transparency with respect to audit obligations and to increase the independence and objectivity of auditors and auditing firms. In particular, the European Parliament and the Council of the European Union, on 3 and 14 April respectively, approved the following acts to be read jointly and as forming an integral whole:*
 - *Regulation (EU) No 537/2014 of 16 April 2014 (hereinafter also "EU Regulation") on specific requirements regarding the statutory audit of public-interest entities, directly applicable, as a primary source of law, with effect from 17 June 2016;*
 - *Directive No 2014/56 of 16 April 2014 (amending Directive 2006/43/EC on statutory audits of annual accounts and consolidated accounts, transposed into our legal system through Legislative Decree No 39/2010), transposed into Italian law on 21 July 2016 through Legislative Decree No 135/2016, which entered into force on 5 August 2016 and amended the provisions of Legislative Decree No 39/2010.*

Regulation 2014/53/EU envisages, inter alia, that the audit report should also contain additional information regarding the most significant assessed risks of material misstatement (Key Audit Matters).

Similarly, the additional report to which Article 11 of the EU Regulation refers replaces and, to a significant degree, expands upon the report on key matters.

In addition, as of 1 January 2018 the following new international accounting standards are to be applied:

- *IFRS 9 Financial Instruments, adopted through Commission Regulation (EU) No 2016/2067 and applicable from 1 January 2018, which replaces International Accounting Standard (IAS) 39 and contains a model for the classification and measurement of financial instruments based on three categories: amortised cost, fair value through other comprehensive income or fair value through profit or loss;*
- *IFRS 15 Revenue from contracts with customers, adopted through Regulation (EU) No 2016/1905 and applicable since 1 January 2018, which replaces IAS 18 and 11. IFRS 15*

introduces a model to identify revenue focused on identifying individual contractual obligations.

Considering the activity of the Poste Italiane Group, the introduction of the above accounting standards, and in particular IFRS 9, has a significant impact on the financial reporting process. The above-mentioned changes regarding the application of IFRS 9 involve a significant amount of one-off activities by the audit company in the course of the financial years ending 31.12.2017 and 31.12.2018. These entail the analysis and comprehension of the approaches identified, the verification of the procedural arrangements and support systems implemented by Poste Italiane, the testing of balances and transactions, including back-testing, in place on the date of the transition. They also involve the periodic performance of new and additional audit activities.

In this regard, on 6 September 2017 Poste Italiane received from the audit firm, in the light of the new legislative framework, a proposed supplement to the nine-year statutory audit mandate for 2017-2019. This contained a description of the subject and purpose of the proposal, the nature of the engagement and of the additional activities, and the corresponding fee adjustment as shown in the attached table (Annex 1).

The fee supplement requested by PwC amounts to €350,000 (excluding VAT) for the three-year period 2017-2019. This sum is broken down as follows: €130,000 for 2017, in consideration of the introduction of the new methodologies, and €110,000 for each of the following two years.

The conferral of the assignment, in line with the provisions of Article 13(1) of Legislative Decree No 39/2010, must be decided by the Shareholders' meeting at the reasoned proposal of the Board of Statutory Auditors.

For the purposes of the preliminary appraisal for which it is competent, the Board of Statutory Auditors took the following action.

- The Board of Statutory Auditors examined PwC's proposal, asking the auditor for further information on its detailed activities, with a quantification of the hours and the mix of*

professionals involved. The fee is calculated by applying the same average hourly fee (about €62/hour) as in the original nine-year contract with a professional mix weighted more towards experts. The auditor pointed out that performing the additional activities in question requires the involvement of professional resources with the relevant experience/level of specialisation. This is because they are related to the introduction of important new developments that have a direct impact on the production of the deliverables (reports on the financial statements, report on significant matters pursuant to Article 11 of Regulation (EU) No 537/2014, declaration of independence, opinion on the annual report's compliance with the law, etc.) and concern the initial application/reporting of complex technical procedures such as those required by IFRS 9.

- The Board of Statutory Auditors also met the head of the Administration and Budget Department of Finance and Audit (AFC), as well as the executive in charge of drawing up the company's accounting documents, to examine with said executive whether the additional activities envisaged by PwC were reasonable, in terms of the description of those activities and the quantification of the hours involved.*
- The Board of Statutory Auditors received from the head of Legal Affairs a statement to the effect that the conferral of the supplementary auditing assignment is compatible with the original nine-year statutory audit contract, given that the original contract envisages the possibility of variations and additional services required or deemed necessary by Poste.*
- The Board of Statutory Auditors received from the head of Administration and Budget and the executive concerned a note in which the former provides an analysis of the request for a fee supplement for the purpose of assessing its congruence. The head of Administration and Budget also provided the outcome of a benchmark analysis which shows that the supplements requested by PwC are in line with the minimum fee increase that the other leading audit firms have asked customers/public-interest entities to pay;*
- The Board of Statutory Auditors received a statement from the head of Procurement to the effect that the assignment is compatible with the public procurement legislation*

and with internal procedures (taking into account that PwC is the only provider to which the assignment can in effect be conferred).

- *The Board of Statutory Auditors received from PwC, on 1 March, the confirmation of independence referred to in Article 6 of Regulation (EU) No 537/2014.*

As a result of the above activities, the Board of Statutory Auditors considers that the request to supplement the audit activities, in the light of the statements provided by the company's departments, is consistent with the statutory audit process as referred to in the engagement currently in place, considering the new audit activities imposed by the new legislative provisions. The Board of Statutory Auditors also considers the assignment to be appropriate with respect to the professional commitment required and in line with the existing economic conditions.

In the light of the above, and in keeping with the terms of the proposed supplement to the nine-year statutory audit mandate requested by the audit firm, the Board of Statutory Auditors proposes that the Meeting confer “The assignment to perform supplementary statutory procedures regarding the financial statements and consolidated financial statements of Poste Italiane S.p.A for each financial year of the three-year period 2017-2019” to the audit firm PwC (entered in the special register envisaged by Article 161 of Legislative Decree No 58/98 (Consolidated Law on Financial Intermediation), with registered office in Milan, Via Monte Rosa, 91, for the total net amount of €350,000 (three hundred and fifty thousand euro), plus VAT, broken down as follows for each financial year: €130,000 (one hundred and thirty thousand euro) for 2017 and €110,000 (one hundred and ten thousand euro) for each of the following two financial years”.

REPORT OF THE BOARD OF DIRECTORS ON THE FIRST ITEM ON THE AGENDA OF THE EXTRAORDINARY MEETING

Change to the Ring-Fenced Capital named “BancoPosta” (BancoPosta’s Ring-Fenced Capital) following the removal of the limitation of purpose with respect to (i) the activities, assets and legally binding agreements constituting the monetics and payment services business branch, as well as (ii) all of the legal relations inherent to back office and anti-money laundering activities. Consequent change to the BancoPosta’s Ring-Fenced Capital Regulations. Further changes to the BancoPosta’s Ring-Fenced Capital Regulations relevant to the rules for the management and control of the BancoPosta’s Ring-Fenced Capital. Consequent and inherent resolutions.

Shareholders,

This Extraordinary Shareholders’ Meeting has been convened to decide on the change to Ring-Fenced Capital named “BancoPosta” (BancoPosta’s Ring-Fenced Capital) consisting of the removal of the limitation of purpose from the same BancoPosta’s Ring-Fenced Capital with regard to the following.

(i) the activities, assets and legal relationships constituting the monetics and payment services business branch (hereinafter the “Business Branch”) are to be transferred – for a non-cash consideration, as subscription of a capital increase just resolved on this purpose by the receiving company – to PosteMobile S.p.A., wholly owned by Poste Italiane, (hereinafter the “Conferral”), which will in turn set it up as a ring-fenced capital so that it can operate as a “hybrid” electronic money institution (ELMI), in accordance with the relevant banking supervision provisions and following the issuing by Banca d’Italia of the necessary authorization. Said activities, assets and legal relationships are set out in the list named “Assets and legal relationships of the Business Branch” (annex 1 thereto) which, taking into account any updates needed to

reflect the situation of the Business Branch at a date closer to that of the Meeting, will be attached as updated to the minutes of the Extraordinary Shareholders' Meeting of Poste Italiane.

At 30 September 2017 the Business Branch to which the Conferral refers was valued by an appraisal referring to that date (based upon the financial situation of the Business Branch at 30 September 2017) and issued pursuant to point (b) of the second paragraph of Article 2343-ter of the Civil Code (hereinafter the "Appraisal") by an expert (Ing. Marco Vulpiani of Deloitte Financial Advisor S.r.l.), who stated his independency and professionalism. In the light of the Conferral, the information on the financial situation of the Business Branch will be updated at 30 April 2018 and will be available in time for the date of the Extraordinary Shareholders' Meeting. The Appraisal will be consequently updated; no significant deviation of the value of the Business Branch as stated in the Appraisal referred to at 30 September 2017 is foreseen. The financial situation of the Business Branch, as updated at 30 April 2018, will then be used in the run-up to the Conferral, which is planned to take place on 1 October 2018, or other date which will be resolved by the Board of Directors of Poste Italiane;

- (ii) all of the legal relationships inherent to back-office activities (i.e. the operational activities performed to ensure the correct management of products and the correct functioning of the services provided to customers) and anti-money laundering activities which it is proposed be returned to the available generic assets of Poste Italiane. These legal relationships and activities are set out in lists named, respectively "Back-office legal relationships" and "Anti-money laundering legal relationships" (annex 2 thereto) which, taking into account any updates needed to reflect the situation of said legal relationships at a date closer to that of the Meeting, will be attached to the minutes of the Extraordinary Shareholders' Meeting of Poste Italiane.

The following should be noted:

- the BancoPosta's Ring-Fenced Capital was set up – for the conduct by Poste Italiane solely of BancoPosta activities as governed by Presidential Decree No 144 of 14 March

2001 as supplemented and amended – by a decision of the Extraordinary Shareholders' Meeting of Poste Italiane on 14 April 2011, effective as of 2 May 2011;

- the same Extraordinary Shareholders' Meeting of Poste Italiane on 14 April 2011 simultaneously approved the regulations governing the organisation, management and control of the BancoPosta's Ring-Fenced Capital (hereinafter also BancoPosta's Ring-Fenced Capital Regulations);
- the competence to change the BancoPosta's Ring-Fenced Capital and/or the BancoPosta's Ring-Fenced Capital Regulations lies with the Extraordinary Shareholder's Meeting of Poste Italiane.

The grounds for the proposed change to the BancoPosta's Ring-Fenced Capital as illustrated above are as follows:

- as regards the removal of the limitation of purpose with respect to the Business Branch – which, as illustrated above, will be transferred through the conferral for a non-cash consideration to PosteMobile S.p.A., which will in turn set it up as a cover pool so that it can operate as a "hybrid" ELMI – the timeliness of creating, within the scope of Poste Italiane Group, a centralised payment and monetics services unit and a competence centre to support the implementation of the Group's digital strategy. It should be noted that, following the operation to remove the constraint on the assets and legal relationships that make up the business branch, and its subsequent conferral to the aforementioned specialised intermediary, the overall level of asset cover for the protection of customers will increase, activities performed and related risks being equal. This is because not only will the allocation already earmarked for the BancoPosta's Ring-Fenced Capital not be reduced – it will, rather, increase as an effect of the input of new assets by Poste Italiane, as described in the proposal submitted to the Extraordinary Shareholders' Meeting under item 2, below, of the agenda – but to this will be added the amount determined by the prudential supervision regulations governing ELMI;

- as regards the legal relationships inherent to back office activities and anti-money laundering activities – which it is proposed be returned to the available generic assets of Poste Italiane – the organisational need to centralise the operations concerned in the Poste Italiane parent company, in order to:
 - (i) with respect to back office activities, reduce costs and provide high quality standards in the services delivered to external customers and at the same time ensure greater effectiveness and efficiency in processing operations;
 - (ii) with respect to anti-money laundering activities, strengthen the anti-money laundering and anti-terrorism organisational structures from a Group perspective, and at the same time reduce the reputational risks arising from any failure to adopt a unified approach to risk management by standardising the assessment of suspect operations.

If approved by the Meeting, the changes to the BancoPosta's Ring-Fenced Capital illustrated above will take effect as follows:

- (i) as regards the removal of the limitation of purpose from the BancoPosta's Ring-Fenced Capital with respect to the Business Branch, once the period referred to in Article 2447-*quater* of the Civil Code has profitably ended, at the time of the subsequent effective date of the Conferral of the Business Branch which is planned to take place, as above indicated, on 1 October 2018, or other date which will be resolved by the Board of Directors of Poste Italiane;
- (ii) as regards the removal of the limitation of purpose from the BancoPosta's Ring-Fenced Capital with respect to all of the legal relationships inherent to back-office and anti-money laundering activities, once the period referred to in Article 2447-*quater* of the Civil Code has profitably ended.

As envisaged by the Supervisory provisions issued by the Banca d'Italia – applicable to Poste Italiane in the light of its post office banking services conducted through the BancoPosta's Ring-Fenced Capital – the Banca d'Italia has issued a provision authorising the change to the BancoPosta's Ring-Fenced Capital following the removal of the limitation

of purpose regarding the Business Branch (as well as the subsequent granting of the same to PosteMobile S.p.A., which in turn will set it up as a the ring-fenced capital so that it can operate as a “hybrid” ELMI). This authorisation has proved to be necessary since the value of the business branch exceeds the significance threshold of 10% of the own funds of the BancoPosta’s Ring-Fenced Capital envisaged by the above-mentioned supervisory provisions.

Both as a consequence of the change to the BancoPosta’s Ring-Fenced Capital resulting from the removal of the limitation of purpose on the Business Branch, and taking into account that it has been deemed opportune to carry out some further changes regarding the rules for the management and control of the BancoPosta’s Ring-Fenced Capital, it is also proposed that some clauses of the the BancoPosta’s Ring-Fenced Capital Regulations be amended, as illustrated below:

- following the removal of the limitation of purpose of the Business Branch, clause 2.1 (points 2 and 6), which sets out precisely the assets and legal relationships dedicated to the conduct of BancoPosta activity, will be amended;
- with reference to the management rules the “BancoPosta Interdepartmental Committee”, whose tasks include liaising between the BancoPosta department and the corporate departments of Poste Italiane, has been eliminated. As a consequence, clauses 4.2, 4.5.5 and 4.6.2 will be amended and clause 4.7 will be removed, since the departments and prerogatives assigned to this Committee have been transferred to the ordinary activity carried out by the existing management committees;
- clauses 4.1. and 4.4.1 concerning the Board Committees will be updated to take into account the creation of the “Related Parties and Connected Parties” Committee, with preliminary, advisory and proposal formulation tasks previously assigned to the Control and Risk Committee;

- as regards the control rules, with reference to anti-money laundering activities clauses 4.3.3, 4.3.4, 4.5.7 and 5.1.1 will be amended in order to reflect the new organisational structure in this matter.

If approved by the Meeting, all the changes to the BancoPosta's Ring-Fenced Capital Regulations illustrated above will take effect at the time of the effective date of the Conferral of the Business Branch which is planned to take place, as above indicated, on 1 October 2018, or other date which will be resolved by the Board of Directors of Poste Italiane.

According to the Supervisory provisions issued by the Banca d'Italia – applicable to Poste Italiane in the light of its post office banking services conducted through the BancoPosta's Ring-Fenced Capital – Banca d'Italia has issued a provision authorising the above-mentioned changes to the BancoPosta's Ring-Fenced Capital Regulations.

Taking the above into account, we therefore submit to you the following

Proposal

The Shareholders' Meeting of Poste Italiane S.p.A, having examined the explanatory report by the Board of Directors and having acknowledged the issuing of the authorization by Banca d'Italia:

hereby resolve

- 1) that it approves the proposed change to the BancoPosta's Ring-Fenced Capital regarding the removal of the limitation of purpose from the BancoPosta's Ring-Fenced Capital with regard to:
 - (i) the activities, assets and legal relationships constituting the monetics and payment services business branch – set out in a list named "Assets and legal relationships of the Business Branch", which will be attached to the minutes of this Extraordinary Shareholders' Meeting of Poste Italiane – with this change scheduled to take effect

once the period referred to in Article 2447-quater of the Civil Code has profitably ended, at the time of the subsequent effective date of the Conferral of the Business Branch to PosteMobile S.p.A., which is planned to take place on 1 October 2018, or other date which will be resolved by the Board of Directors of Poste Italiane;

- (ii) all of the legal relationships inherent to back-offices and anti-money laundering activities – set out in lists entitled, respectively, “Back-office legal relationships” and “Anti-money laundering legal relationships”, which will be attached to the minutes of this Extraordinary Shareholders’ Meeting of Poste Italiane – with this change scheduled to take effect once the period referred to in Article 2447-quater of the Civil Code has profitably ended;
- 2) to approve the proposed amendments to the BancoPosta’s Ring-Fenced Capital Regulations – the coordinated text of which, with the amendments, will be attached to the minutes of this Extraordinary Shareholders’ Meeting of Posta Italiane – in accordance with the points set out in the explanatory report by the Board of Directors under item one of the agenda of the extraordinary session of this Meeting, with these changes scheduled to take effect as above resolved under point 1), let. (i);
 - 3) to confer a mandate on the Chief Executive Officer, with powers of sub-delegation, to approve and introduce to this resolution any amendments, additions or deletions that may prove to be necessary for the purposes of recording it in the Companies Register and/or upon request of Banca d’Italia.

REPORT OF THE BOARD OF DIRECTORS ON THE SECOND ITEM ON THE AGENDA OF THE EXTRAORDINARY MEETING

Contribution of new capital instruments by Poste Italiane S.p.A. to BancoPosta's Ring-Fenced Capital in order to rebalance the leverage ratio. Inherent and consequent resolutions.

Dear Shareholders,

you have been called to attend an extraordinary session to resolve on the contribution of new capital instruments by Poste Italiane SpA ("Poste Italiane") to the Ring-Fenced Capital named "BancoPosta" (BancoPosta's Ring-Fenced Capital), involving the assignment of free reserves amounting to EUR 210 million, in order to rebalance the leverage ratio (as defined below) to the target values established in the BancoPosta Risk Appetite Framework approved annually by the Poste Italiane Board of Directors.

The leverage ratio is defined as the percentage ratio between BancoPosta's capital endowment (to be precise, its equity for the purpose of supervisory regulations) and the total value of the assets of BancoPosta's Ring-Fenced Capital itself, including corrections for derivatives and off-balance sheet items, and measures the financial leverage risk, i.e. the risk that a particularly high level of debt compared to equity will make the intermediary vulnerable.

This index is included in the BancoPosta Risk Appetite Framework, which is the document in which the risk appetite, the risk tolerance thresholds, risk limits and risk management policies, as well as the relevant processes needed to define and implement them, are annually defined by the Board of Directors of Poste Italiane.

In particular, in view of the current equity of BancoPosta's Ring-Fenced Capital, which amounts to € 2,059 million, the leverage ratio as at 31/12/2017 stood at 3.11%. Certain specific circumstances, including (i) the entry into force of the new IFRS9 accounting

standard, the application of which from 1 January 2018 entails for BancoPosta an increase in the value of the assets recorded in the financial statements and (ii) the increase in collection volumes and asset values (based on the forecasts made in the 2018-2022 Strategic Plan presented to the markets on 27 February 2018), mean that, in the absence of any action taken to increase its equity, this indicator could fall below 3%, which represents the minimum limit set both by the BancoPosta Risk Appetite Framework and banking supervisory regulations.

The proposal is therefore for Poste Italiane to intervene by assigning free reserves of EUR 210 million to BancoPosta's Ring-Fenced Capital, in order to strengthen the equity of BancoPosta's Ring-Fenced Capital and bring the leverage ratio back to levels compatible with the objective established in the Risk Appetite Framework (leverage ratio of at least 3.15%).

With this respect it should be noted that the need of strengthening the equity of BancoPosta's Ring-Fenced Capital is not connected to the removal of the limitation of purpose with respect to the business branch dedicated to the monetics and payment services (referred to, among other things, in the first item on the agenda of the Extraordinary Meeting), given that such deal does not entail a significant change of the value of the assets taken into account for the calculation of the leverage ratio. The two proposed deals are coherently aimed at ensuring an adequate equity hedging of the regulated activities carried out by the Poste Italiane Group.

In accordance with the Supervisory Provisions issued by the Bank of Italy – applicable to Poste Italiane because of its post office banking business conducted through BancoPosta's Ring-Fenced Capital – the Bank of Italy has issued a specific authorisation for the transaction described above.

In view of the above, we therefore submit the following

Proposal

The Shareholders' Meeting of Poste Italiane S.p.A., having examined the explanatory report of the Board of Directors and having acknowledged the issuing of the authorization by Banca d'Italia:

resolves

- 1) to approve the assignment by Poste Italiane of free reserves of EUR 210 million to Patrimonio BancoPosta, in order to rebalance the leverage ratio to the values established in the Risk Appetite Framework approved by the Board of Directors;
- 2) to mandate the CEO, with the power to sub-delegate, to perform any activity and to negotiate and sign any document that may be required or appropriate to implement this resolution.
