("**Equita Group**" or the "**Company**") sent to Consob, pursuant to and for the purpose of Article 108, paragraph 2 of the Consob Regulation no. 11971 of 14th May 1999, as amended ("**Issuers' Regulation**"), the communication of issuers of shares widely distributed among the public (Annex 3G-*bis* – Issuers' Regulation).

Such communication follows the execution of the resolution taken by the Shareholders' Meeting on 16th April 2018 to distribute dividends and the acknowledgement by the Company that the threshold provided by Article 2-*bis*, paragraph 1, letter (a) of the Issuers' Regulation (therefore, the exceed of five hundred shareholders) has been exceeded.

Obligations bearing on Equita Group as issuer of shares widely distributed among the public will be effective starting from 1st January 2019 – excluding the case in which the Company is already listed on a regulated market, organized and managed by Borsa Italiana S.p.A., on such date – .
