REPORT - BUY BACK PROGRAM

Milan, 18 June 2018 – Openjobmetis S.p.A. – Agenzia per il lavoro communicates the transactions on own shares for the period between 11 June 2018 and 15 June 2018 within the limits resolved by the shareholders’ meeting on 24 April 2018 (as already communicated to the market with the press releases on 24 April 2018 and 15 May 2018). As a consequence of the transactions carried out within the buy back program, Openjobmetis holds a total of 121,142 own shares equal to approximately 0.883% of its share capital.
