ALESSANDRO SPADA



Alessandro Spada was born in Monza in 1965 and, after graduating in Law and studying a year in the USA in 1991, he started his working career in a professional office; in 1992, he joined VRV S.p.A. – the family owned company, specialized in design and manufacturing of pressure vessels and heat transfer equipment for the Oil & Gas, chemical, petrochemical and Cryogenic industries - first as Assistant to the Sales Department, later as Sales Director and then as CEO of the Energy & Petrochemical Division.

Today, Alessandro Spada is PRESIDENT of VRV S.p.A. and he also holds the following roles, within VRV Group: In 2001 he was appointed as Chief Executive Officer of Cryo Diffusion SA (France).

In October 2015 he was appointed as President of IMB Industrie Meccaniche di Bagnolo

Since March 2008, he is a Member of the Board of Directors of VRV India Cryogenic Equipment PVT – Ltd.

In 2010 he became a Board Member of FEMA S.r.l. (valve company which is part of VRV Group).

Outside the VRV group

Since June 2017 he became Vicar Vice-President of Assolombarda Confindustria Milano Monza and Brianza for Medium Enterprises.

Since May 2009 he became Member of Executive Council of Confindustria (Italian Entrepreneurial Association)

Since January 2018 President of Parcam (100% Milan Chamber of Commerce-Monza-Brianza-Lodi)

Since September 2017 Board Member of Milan Chamber of Commerce-Monza-Brianza-Lodi

In the past years, Alessandro Spada has been appointed:

From 2013 to July 2017 Vice-President of Assolombarda for institutional relations, Internationalization activities, energy and environment.

From 2013 to 2016 Member of the Board of Directors of Il Sole 24 ORE S.p.A.

From 2007 to 2014 Member of Scientific Committee of Politecnico Foundation of Milan.

From 2007 to 2014 Chairman of Innovhub, a special company for innovation of the Chamber of Commerce of Milan.

From 2007 to 2010 Member of the Board of Directors of ExpoCTS S.p.A and, from 2007 to 2009, Member of the Committee "Fabbrica del Vapore" of Milan and member of New Business Point Committee of CCIAA Milan.

In the period between 2005 and 2007, he has been the President of Young Entrepreneurs of Assolombarda.
