PUBLICATION OF SUSTAINABILITY REPORT FOR 2017

Milan, June 29th, 2018 – **COIMA RES S.p.A. SIIQ** (“**COIMA RES**” or the “**Company**”) – a listed real estate company specialised in the investment and management of commercial properties in Italy – announces that it has published its Sustainability Report for the year 2017 (the “**Sustainability Report**”).

The Sustainability Report complies with the European Public Real Estate Association Sustainability Best Reporting Guidelines (EPRA sBPR) and is also inspired by the GRI Standards published by the Global Reporting Initiative. The Sustainability Report offers to our stakeholders a renewed perspective on our approach in terms of innovation, sustainability, portfolio performance, tenant satisfaction, energy and resource savings as well as on the wellness of our tenants.

In 2017, we have expanded the use of the Kingsley Index to cover 100% of our properties to optimise and fine-tune relationships with our tenants and with a view of involving them in our journey towards reducing the consumption of resources and towards increasing the level of comfort and wellness of our properties. As a demonstration of the quality of our real estate portfolio, at the end of 2017, c. 74% of our properties were either LEED Certified (or suitable candidate for certification).

In 2017, we reiterated our focus on innovation and sustainability by creating a European Think Tank with five other listed real estate companies (alstria, Colonial, Gecina, Great Portland and NSI) with the objective of sharing and drawing from our various experiences in the fields of innovation and sustainability.

Lastly, in 2017 our governance was also strengthened by the arrival of two new independent directors with international experience in our Board, aligning our governance with the best international practices in the real estate sector.
